Nowlin Ranch

Project 4843

This conservation project on a working ranch includes a term easement, mesic restoration, and wildlife friendly fencing on nearly 4,500 acres of private land. The project is a joint effort between the landowner, NRCS, Winnett ACES, World Wildlife Fund, and MSGOT NRCS, through the RCPP program, WWF and Winnett ACES will assist the landowner with mesic restoration and wildlife friendly fencing. Mesic area restoration will cover approximately 35 acres and five meadow, coulee, or stream areas. Fencing will remove woven-wire fence and replace with 3 or 4 strand fences with a smooth bottomwire. The landowners will provide most of the labor for the projects, including time managing a grazing plan developed with the NRCS. The property is located within the Central Service Area.

It is anticipated that Petroleum County Conservation District will hold the lease. Terms and costs to be paid to the CD will be completed under a separate grant.

This Stewardship Account grant request is only for a term conservation easement of 15 years.

Based on the Program's HQT the project is located in lower quality habitat but the implementation of NRCS restoration projects should result in uplift that can be added into the project at a future date. The USGS has mapped the Nowlin parcels as important core habitat with growth opportunity lands.

The Program recommends application of lek multipliers for all 2022 proposed grant projects. This would be comparable to how calculations are done for development projects.

This project was calculated with the base cost of \$13/credit. Credits available after application of the 40% baseline are 11,769.10. With the application of multipliers for leks, 22,361.30 credits would be created for this project. The project credits with application of lek multipliers would allow up to \$238,295.34 in funding for this project. The Program recommends adjusting the baseline to meet the project costs plus the cost of the conservation district expenses.

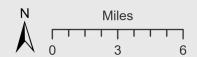

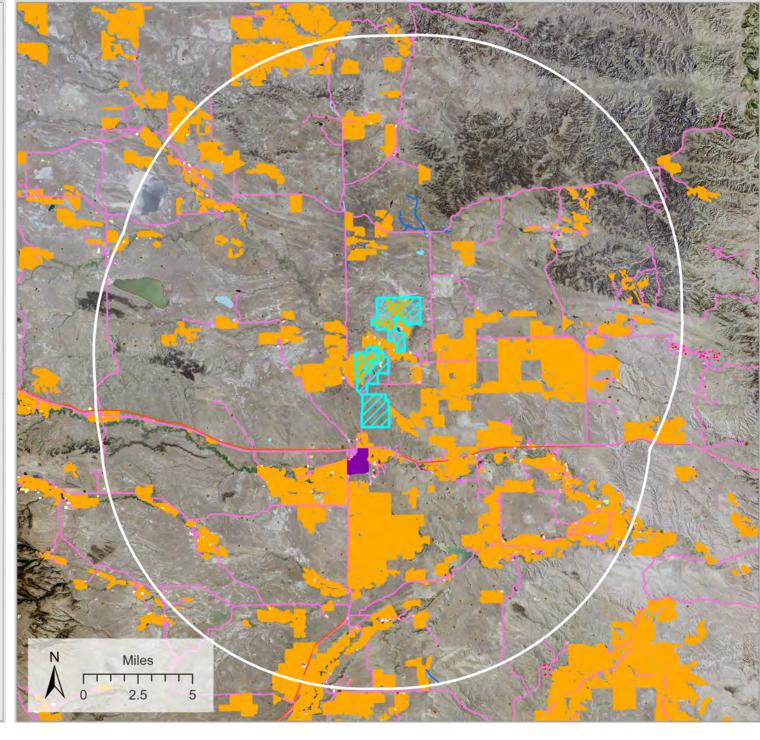
